

**Guest Waiver, Release, and Indemnity Agreement
Coronavirus/COVID-19**

THIS GUEST WAIVER, RELEASE, AND INDEMNITY AGREEMENT (the Agreement")
entered into this

(hereinafter the "Guest")

in favor of Salt Log Outfitters, LLC, a Georgia limited liability company, and Wilkinson Oconee, LLC,
a Georgia limited liability company, their agents, successors, associates, assessors, and assigns
(hereinafter the "SLO Companies")

WITNESSETH:

WHEREAS, the novel coronavirus ("COVID-19") has been declared a worldwide pandemic, spread by the World Health Organization, spread mainly from person-to-person contact; and

WHEREAS, as a result, federal, state, and local governments, and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people; and

WHEREAS, the SLO Companies operate a commercial outfitting and guide program wherein guests and their invitees engage in hunting activities on real property located in Wilkinson County, Georgia (the "Premises"), reside in lodging on the Premises, and dine at facilities on the Premises (collectively, the "Activities"); and

WHEREAS, the SLO Companies have put in place preventative measures to reduce the spread of COVID-19, but cannot guarantee that Guest will not become infected with COVID-19; and

WHEREAS, Guest acknowledges that by signing this Agreement, Guest is prohibited from bringing a suit based on negligence, or otherwise, against the SLO Companies should Guest or others contract COVID-19.

NOW THEREFORE, in conjunction of the mutual covenants contained herein, Guest being permitted to engage in the activities, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Guest agrees as follows:

Guest acknowledges the contagious nature of COVID-19 and voluntarily assumes the risk that Guest may be exposed to or infected by COVID-19 while attending Activities on the Premises, and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

Guest understands that the risk of becoming exposed to or infected by COVID-19 at the Premises may result from the actions, omissions, or negligence of Guest and others, including, but not limited to, Salt Log Outfitters Companies employees, volunteers, and program participants, and their families.

Guest voluntarily agrees to assume all of the foregoing risks and accepts sole responsibility for any injury to Guest related to the contraction of COVID-19 at the Premises, including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense of any kind, that Guest may experience or incur in connections with Guest's attendance at the Premises and engagement in the Activities.

Guest releases and forever discharges the SLO Companies, their employees, agents, attorneys, successors, associates, and assigns, and all other persons, firms, or corporations of and from any and every claim, demand, right, or cause of action, of whatever kind or nature, related to Guest's contraction of COVID-19, including but not limited to any claims to actions, omissions, or negligence of the SLO Companies whether a COVID-19 infection occurs before, during, or after attending any SLO Company activity, and any illness, damage, loss, claim, liability, or expense, of any kind, that Guest may experience or incur in connection with Guest's attendance at the Premises. Guest further agrees to indemnify and hold the SLO Companies harmless from any and all claims whatsoever by third parties who may contract COVID-19 and claim such contraction is a result of Guest's stay at the Premises, including family members and invitees, which arise out of or in connection with Guest's activity described herein.
